

For the thermal renovation of the least energy performant housing, loans with a subsidized interest rate are available. This eco-loan was intended for the category of the least efficient dwellings (Class E, F and G). Since September 2010, it was open to Class D dwellings.

NATIONAL REGULATORY AND POLICY CONTEXT

Social Housing Organizations are key players in the increasing the energy performance of buildings. The Social Housing movement in France has three main objectives on this issue:

- Increasing comfort for tenants
- Reducing the impact of price changes of energy on living costs
- Reducing greenhouse gas emissions and conserving natural resources

As part of the French Environment Strategy termed the 'Grenelle Environment Forum', the Social Housing movement in France is committed to:

- Renovate 800,000 of the least energy performant homes
- Ensure that new homes meet the 50 kWh / m² standard by 2013, already on 1 July 2011 for Urban renovation Programme

OUR ACTIVITIES

On 25 May 2010, as part of a workshop organized by Power House France three roundtables on the theme 'Energy Performance: European added value' were held. Opening the workshop, Pierre Quercy recalled "This is an opportunity for participants to learn and exchange experiences and get informed on the prospects for future EU funding". "The housing sector has a potential demonstration role to play, and may become, at European level, a key sector for ambition, in terms of energy efficiency, economic efficiency, quality of use and collaboration with residents."

In his speech, Pierre Quercy also outlined a possible path for the future of social housing on the European stage and stressed the importance of sharing knowledge with our European counterparts, learning from our experiences and, finally, being sustainable. "

THE BIG GREEN HOUSING EXCHANGE

Power House at the HLM Congress



For the second time now. the platf o r m Power House France HLM was at the conference held Strasbourg on 28, 29

and 30 September 2010. The conference brings together:

- Delegates representing all the agencies: presidents, directors, technicians
- Members of government, elected officials, major institutions and social and economic partners of the Movement
- Guests regional, national, international,
- Building industry experts, companies, service companies
- Journalists from radio, television, national and regional newspapers and trade press.

This brings to nearly 10,000 the number of people present to Congress.

The Working Group Power House France bringing together "Europe, Energy and Social Housing organization representatives" met three times in 2009 / 2010. The next meeting is scheduled November 30, 2010.

We publish regular reports, brochures, articles on the results of European projects or on the experiences of our counterparts.

Thus, with these events and thanks to good cooperation between France and the Power House project coordinators, more and more members are seeking European experiences to refine their thinking, test innovative methods. For example, some agencies seek BE-

WARE project representatives to training on the involvement of local residents to save energy or ANAH (private park) Power House sought to find out experiments on the fight against fuel poverty.

Partners in Power House

- The Deposit and Consignment Office, public bank, the main funder of social housing in France, especially eco loan supports Power House France through its agreement made with the Social Union for habitat.
- Gas Distribution Networks and France (GRDF) is also a partner in Power House France. The agreement with the Social Union for Housing is being signed.
- EDF has expressed interest in participation.

EXCHANGE

POWER HOUSE France: tools for housing agencies and their partners:

The platform has produced a number of tools to meet the needs of housing agencies:

- Publication of a report "Energy efficiency: Europe supports your project." This report contains a summary of EU energy policies, a presentation of the ERDF measure to improve the energy performance of dwellings, calls on European energy projects of interest to social housing bodies and the results of projects. He was sent to a total of over 1,000 professionals HLM and HLM distributed at the conference in Strasbourg on 28, 29 and 30 September 2010.
- A booklet "Energy performance of social housing, ERDF: mobilization of the movement HLM. This work, done in collaboration with regional associations HLM, assesses progress in the use of the measure ERDF in France for the retrofit. It was broadcast at discharge and sent to the Strasbourg Regional Associations HLM, this tool allows them to communicate with their partners including the local level.


This report shows ERDF t h e amounts available for retrofit projects by region, 70% of the amounts available in France, the expected per-
